First and foremost, I wanted to create the Atlantic County Bar Association Foundation, non-profit 501(c)(3) that would spearhead charitable efforts for the ACBA. I am happy to report the ACBA Foundation has been established. The Haneman-Perskie Scholarship is now part of and included in the foundation. In addition, the ACBA Foundation just held our first event- our annual golf tournament. The proceeds from the golf tournament will benefit the ACBA Foundation, future scholarships and philanthropic donations to agencies connected to or impacted by the law.

While focusing on establishing the ACBA Foundation, the Board of Officers and Trustees have also been working on updating the ACBA by-laws. Our by-laws have not been updated in over fifteen (15) years. Updating our by-laws recognizes how the practice of law has changed, including up-to-date technology, voting by email, notice to the association and more inclusive language. This project has been spear-headed by President-Elect Van MacPherson, Joanna Sykes-Saavedra and Jake Perskie. The new by-laws will be disseminated shortly to membership for a full vote.

Next, I wanted to re-energize camaraderie, mentoring and networking among our membership. As such, we have reinstated Bar at the Bar Event. For those who have not attended a Bar at the Bar Event, it is a networking event that doesn't cost anything to attend. We already held two Bar at the Bar Events with approximately 30-40 members at each. It is a great event attended by experienced lawyers, judges as well as attorneys in our Young Lawyer Division. Our next event is November 2, 2023 at Bocca in Margate.

ACBA is committed to providing quality CLEs and programs throughout the year. On October 12, 2023, Vice-President Rick McKelvey and chair of our CLE Committee organized a Professionalism CLE that focused on Lawyer Wellness. A topic that the ACBA will be focusing on throughout the year. The dynamic panel of speakers included our Assignment Judge, the Honorable Michael Blee, A.J.S.C., Moderator and NJSBA Professional Award Recipient for Atlantic County, Eric Wood, Fox Rothschild, Scott Sherwood, Deputy Public Defender and Vice President of District 1 Ethics Committee, and John Koufous.
